Changes to Smoke Alarm Laws

The Queensland Government passed new smoke alarm legislation that specifies that every Queensland residence will need to be fitted with photoelectric, interconnected smoke alarms in all bedrooms and hallways. These photoelectric smoke alarms can be hardwired by an electrician or there is an option to install alarms that can be interconnected wirelessly and contain a 10-year lithium battery.



There will be a 10 year phased rollout of the legislation, but any significantly renovated or new houses completed after January 1, 2017 will need to comply. All houses leased or sold will also need to meet compliance after 5 years and all owner-occupied private dwellings will need to be compliant within 10 years.

Credit and Debit Surcharges

A ban to stop large businesses from charging excessive payment surcharges when people pay via credit, debit and prepaid card payments came into effect on the 1st of September 2016. The ban will also apply to other businesses from September next year.

Large businesses who are charging payment surcharges are now only allowed to pass on the actual costs that they were charged for accepting the particular payment type. However, taxi services are excluded from this. The ban applies to transactions paid for by: EFTPOS (debit and prepaid); MasterCard; Visa and American Express "companion cards" (not issued directly through American Express but through an Australian financial service provider). Typically, MasterCard and Visa credit transactions cost businesses up to 1-1.5%.

Pension Changes

The assets thresholds for pensions will change from January 1, 2017. The amount of assets you can own and qualify for a full pension will increase and more people will be eligible for a full pension. However, some current part pensioners will lose eligibility due to changes in taper rates.

Currently, for every \$1,000 of assets over the threshold, the fortnightly payment is reduced by \$1.50. From January, this will change to \$3.00. The following tables set out the current assets thresholds and those that will apply from January 1.

The first table shows the amount of assets that you can own and still receive a full pension. The second table shows the amount of assets beyond which you would not receive a part pension. However, these part pension figures may change if the pension rate changes on 20 September 2016.

All pensioners who lose their part pension as a result of the changes will automatically get a Health Care Card.

Footpath Gardens

Brisbane City Council recently changed the rules to allow residents to plant gardens on the verges/footpaths outside their homes.
